

Report Shows Broken Arrow Roads in Good Condition

Broken Arrow’s streets are the City’s largest asset, valued at \$576.1 million dollars. Earlier this year, we retained IMS Infrastructure Management Systems to determine the condition of the City’s vast network of streets. Knowing the condition of each road helps us prioritize repair schedules and propose street projects for General Obligation Bonds.

During the December 6, 2016 City Council meeting, IMS Infrastructure Management Systems presented the results of their data collection analysis. Here are the highlights of that report:

- Broken Arrow’s roads are in overall good condition and surpass the national standards.
- IMS estimates a budget of just over \$6 million a year is needed to maintain the quality of our roads. Sales tax revenue allotted for street maintenance only provides half that amount; therefore, major road projects will need additional funding through General Obligation Bonds going forward. The list of work to be done each year will be in the Financial Report distributed in September.

\$18.7 Million in New Projects to Begin in Broken Arrow

The City of Broken Arrow is selling \$18.7 million of General Obligation (GO) Bonds approved by voters in 2014. The sale will pay for several streets, public safety, parks improvements, and stormwater projects. Approximately \$30.1 million of authorized 2014 bonds remain and will be sold over the next two years.

“With the upcoming bond sale, we will be able to move forward on projects that are important to our residents,” said Broken Arrow City Manager Michael Spurgeon. “We’re excited to complete these necessary improvements that will continue to enhance the quality of life in our community.”

PROJECT HIGHLIGHTS

STREETS

- * Widen 23rd Street (193rd E Avenue/County Line Road) to five lanes between Kenosha (71st Street) and Houston (81st Street): \$2.5 million
- * Widen Olive Avenue (129th E Avenue) to four lanes between Albany (61st Street) and Kenosha Street: \$1 million.
- * Widen Kenosha Street between Date and Main Street to five lanes: \$1.89 million
- * Resurface Kenosha Street between Garnett and Aspen Avenue (145th E Avenue): \$1.05 million

QUALITY OF LIFE (PARKS & RECREATION)

- * Construct Rose West dog park and trailhead restroom: \$473,000

Crime Prevention Specialist Recognized for Work

The Broken Arrow Chamber of Commerce has selected Lisa Ford, the Crime Prevention Specialist and Community Liaison for the Broken Arrow Police Department, as one of the recipients of the 2016 Community Impact award. The Community Impact award is part of the Successful Women’s Luncheon series, which brings together women who are active in the Broken Arrow community. Ford was nominated alongside 15 other women who have contributed to Broken Arrow.

Ford was hired by the Broken Arrow Police Department as their Crime Prevention Specialist in June of 2001. Before coming to BAPD, she worked for the Citizens Crime Commission, where she oversaw the Alert Neighbor, Crime Stoppers, and Arrest Arson programs. Ford manages the Volunteers in Police Service program for the department, which has more than 200 volunteers currently participating. She has also instructed over 100 other law enforcement agencies on running successful volunteer programs through the Oklahoma Regional Community Policing Institute.

- * Construct adult softball complex, regional playground, restrooms, picnic pavilion, and add security lighting at Chisholm Trail South Park: \$1.55 million
- * Construction new splash pad and playground at Leisure Park: \$368,000
- * Construct a community trail network: \$500,000

STORMWATER

- * Construct drainage improvements along Albany Street between 9th Street (Lynn Lane/177th E Avenue) and 23rd Street: \$850,500
