Early Voting Begins Thursday for Vision 2025 Renewal

Broken Arrow, Okla. (11/4/2015) – Early voting begins Thursday for Broken Arrow's public safety and streets propositions, which will generate funding to hire 20 new police officers, 20 new firefighters and improve streets, sidewalks and traffic flow.

If approved, the two propositions will replace the existing Vision 2025 sales tax, so there will be **NO** tax increase in Tulsa County. The Wagoner County portion of Broken Arrow will see a slight tax increase of 55 hundredths of a penny (\$0.0055).

The election is open to all registered voters living within the Broken Arrow city limits in both Tulsa and Wagoner Counties. Early in-person absentee voting is available during the following times:

Broken Arrow voters will see two propositions on the ballot regarding the sales tax renewal:

Proposition 1: Establish a sales tax of three tenths of one penny (\$0.003) to hire additional police officers and firefighter/paramedics; as well as fund the acquisition and replacement of public safety vehicles, equipment, technology and apparatus.

Proposition 2: Establish a sales tax of twenty-five hundredths of one penny (\$0.0025) for the purposes of improving, constructing, and maintaining city streets, sidewalks, and related stormwater appurtenances, including the installation of traffic control devices and signalization.

Tulsa World Editorial: For Broken Arrow and Bixby proposals to extend Vision taxes

Voters in Broken Arrow and Bixby will consider extensions of Vision 2025 sales taxes on Tuesday for improvements in local government services.

In both cases, city leaders have made a rational case for the 0.55 percent tax extension, and the measures have our endorsement.

Broken Arrow: Leaders of Oklahoma's fourth largest city are asking city voters to make the Vision tax permanent and dedicate funding to public safety and transportation.

The Vision renewal would fund 20 new firefighters and 20 new police officers over the next five years. New public safety equipment also is part of the plan. The city has one first responder for every 686 people, which compares to 1-in-378 in Tulsa.

The funding would triple the current budget for the Broken Arrow Streets Department. Any growing suburb has to think about the streets needed to keep up with that growth.

Bixby: The Bixby Visionalso targets public safety and infrastructure. A companion set of proposals would fund parks without raising taxes.

0.3 percent from the Vision extension would be used for a 20-year, \$20 million Arkansas River and downtown corridor development plan.

Another 0.25 percent of the Vision extension would provide permanent funding for four additional firefighters, four police officers, and four other city employees.

On the same ballot, Bixby voters will be asked to extend and reallocate a 2006 0.5 percent municipal tax for parks. The park tax reallocation would emphasize park maintenance, although there would still be money set aside for improvements.

Neither Broken Arrow nor Bixby voters are being asked to increase their tax rates. The measures would only extend current taxes and refocus the Vision tax on projects in the communities where the taxes will be collected.

The measures don't affect consideration of similar Vision extensions in Tulsa, but would mark the first communities to buy into the rubric proposed by Mayor Dewey Bartlett and suburban leaders in March to move the vast majority of the Vision tax from the county to the municipal level.
