### **Battle Creek Golf Club – May Review**

#### General

May was a really strong month financially with total revenues for the month at \$189,862. This put total revenues at \$6,808 more than budgeted revenues (\$183,054) and \$55,678 more than last year for May. Managers were busy this month training new seasonal staff employees in their respective departments on job duties and responsibilities with the busy golf season ahead.

#### **Golf Operations**

Battle Creek Golf Club hosted a Titleist fitting by appointment, which was 1 of 2 in the region. Players from across Northeast Oklahoma came to Battle Creek to get fitted by Titleist Staff during a one on one session. This event generated over \$4,000 in sales directly plus the additional revenue from greens fees, merchandise, food, and drinks. This event has been a big success for the club and brings recognition in for the City and the Facility due to the limited availability of like events in the area. Also during the month the club hosted a Titleist golf ball fitting where players could be fit for the proper Titleist golf ball based on their own individual swing. Players were given sleeves of balls based on their fitting at no charge and there was no cost for them for the fitting as well.

The club saw a 41.5% increase in green fee revenue over last May due to increased foot traffic mainly due to weather. The club saw a 27% increase in membership fees over last May. Merchandise revenues beat budget by 17% due to the increase in rounds over last year. These factors combined lead to the golf shop increasing total revenue over last May by 44%.

Battle Creek Golf Club hosted a total of 15 outside events, which was up 47% over last May's total of 8 events. The club also hosted a total of 5 leagues this year up 250% over last year's 2 leagues. Our goal in hosting more leagues this year is to increase revenues during non-peak times. These leagues are held on weekday evenings, which are typically slow for the club. These leagues bring in \$25 per player with an average of 16-20 players per league. This revenue helps boost the clubs bottom line by filling vacant tee times the club would normally not fill.

# Fireworks Permits Available now through July 3

Must have permit to discharge fireworks within Broken Arrow City limits

**Broken Arrow, Okla.** (6/16/2016) – Residents of Broken Arrow who would like to legally discharge fireworks in the City limits may do so by purchasing a fireworks permit for \$20. Permits are available for purchase online through July 3. In-person permit purchases must be made before City Hall closes at 5:00 p.m. on Friday, July 1.

Applicants for permits must be 18 years of age to apply for and obtain permits. Permits may be applied for online at <a href="www.brokenarrowok.gov/fireworks">www.brokenarrowok.gov/fireworks</a> 24 hours a day, 7 days a week. Permits may also be purchased in person at Broken Arrow City Hall, One Stop Center (north end of City Hall) 220 S. First Street. Permits will not be issued to persons under 18 years of age. It is unlawful to discharge fireworks within City limits without a permit. Certain restrictions apply.

Permits are valid during the hours of 3:00 p.m. -11:00 p.m. July 3 and 4 only. There are also special notes and comments listed on the printed permit. A printed permit is required on the premises where the fireworks are discharged.

Fireworks must be discharged on a noncombustible surface of sufficient size to contain the entire ground portion of the display, not closer than 25 feet to any permanent structure. The permit holder is responsible for the cleaning up of debris caused by discharging of the fireworks. Failure to do so may result in fines of \$225.00 plus cost.

## Recycling Event this Saturday to Collect E-Waste, Tires

**Broken Arrow, Okla.** (6/16/2016) – The City of Broken Arrow, in partnership with the Metropolitan Environmental Trust (M.e.t.), will hold an E-Waste and tire collection event on Saturday, June 18 from 9:00 a.m. to 2:00 p.m. at Central Park, 1500 S. Main Street.

The purpose of the event is to offer residents a convenient way to dispose of their unwanted electronics and tires properly. Abandoned tires fill with water and act as mosquito breeding grounds, which can spread diseases such as West Nile and Zika. E-Waste contains harmful materials such as mercury, lead and cadmium, which should stay out of the landfill.

- Only E-Waste and tires will be collected.
- There will be no charges for general household tire and E-Waste.
- 15 tire limit per person.
- There is a 50-pound E-Waste weight limit.
- Citizens will need to pay \$10 for monitors and \$21 for TV sets (Residents can pre-pay any recycling fees online on the M.e.t. website).
