Definitions

- **Priority 1 =** Crimes in progress involving life threatening circumstances and situations that produce or are likely to produce serious bodily injury or death to any person.
- Priority 2 = Crimes in progress or that have just occurred, incidents in progress that present the potential for injury or property damage/loss, situations where the suspect is still at the scene or in the area and will elude apprehension or create the potential for injury or property damage if the police do not arrive rapidly, incidents where an officer is needed to secure a scene or witnesses, and incidents where there is a need for crowd control or traffic control which, if not done immediately, would create the imminent potential for injury or property damage/loss.
- **Priority 3 =**Crimes against people that are misdemeanors in progress or that have just occurred, reports of recent felony crimes, suspicious circumstances with no threat of injury, and incidents that do not require an officer immediately, but need investigation, mediation, or intervention.
- **Priority 4 =**Property or service related calls for an officer to respond that cannot be handled by telephone, misdemeanor reports when caller demands officer or when an officer needs to investigate the scene or interview witnesses, and requests for officers that do not require a quick response.




Broken Arrow Police Department March 2020 Calls For Service




Priority 5 = Primarily officer-initiated calls or ten-codes used for in-house purposes.


Priority 6 = Calls for Animal Control Officer response.


Priority 7 = Calls for Standby Public Works services, i.e., water, sewer, streets, electrician, etc.





City of Broken Arrow cancels emergency proclamations

Begins reopening in phases April 24 following Governor's Bounce Back Plan

On April 22, 2020 Governor Stitt's Bounce Back Advisory group issued the Oklahoma Bounce Back Plan implementing a three phased approach to open Oklahoma's economy starting on April 24, 2020. The plan is based on scientific modeling from public health experts and is designed to mitigate the risk of the resurgence of COVID-19. It provides a detailed plan for the reopening of Oklahoma's economy in phases that the City of Broken Arrow desires to implement.

In support of the Governor's plan, Mayor Craig Thurmond will terminate the City's emergency declarations regarding sheltering in place effective at 11:59 p.m. on April 23, 2020. However, the City will continue following the Governor's Safer at Home order for vulnerable populations through May 6.

"The City Council discussed the local proclamations in place in connection with the pandemic for BA at its meeting last Tuesday night. My fellow City Councilors and myself, as well as our City Manager and his staff feel the governor's plan is sensible and Broken Arrow will follow a plan consistent with the Governor's," Thurmond said.

The City is working on a recovery plan for businesses and has set up a joint task force with the Broken Arrow Chamber of Commerce and Economic Development Corporation called "BA Rising". Businesses can access resources by visiting www.BArising.com. City Manager Michael Spurgeon has also set up three internal recovery task forces to focus on these areas: Organizational Operations, CARES Act & Stimulus Opportunities, and Economic Recovery.

"We will begin the reopening in phases, and with specific guidance from the President and the Governor," Spurgeon said. "We will be spending the next week preparing to work with businesses and other organizations as outlined in the Governor's plan to open on May 1."

Background

On March 15, 2020, the Governor of Oklahoma issued Executive Order 2020-07 declaring an emergency caused by the impending threat of COVID-19 to the people of Oklahoma and the public's peace, health and safety.

The City of Broken Arrow issued emergency proclamations related to the COVID-19 pandemic on March 19, 2020 and March 31, 2020. The March 19th proclamation ordered the closing of certain business and commercial establishments in Broken Arrow either in-full, or with special conditions for limited operation.

On March 31, 2020 Mayor Thurmond proclaimed an Amended Emergency Proclamation, ordering all citizens in or visiting the City of Broken Arrow to shelter at their place of residence except for "Essential Activities". This Shelter in Place order went into effect on April 1 and was set to expire April 30.

On March 24, 2020, the Governor amended his Executive Order requiring vulnerable individuals to stay home except for essential errands, closing non-essential businesses in counties with confirmed cases of COVID-19, suspending certain elective and minor medical procedures, prohibiting gatherings of 10 or more individuals and restricting visitation at nursing homes; and on April 15, 2020 Governor Stitt extended his Safer at Home order for vulnerable individuals until May 6, 2020.

TERMINATION OF MARCH 16, 2020 PROCLAMATION OF EMERGENCY, MARCH 19, 2020 PROCLAMATION OF EMERGENCY AND MARCH 31, 2020 AMENDED PROCLAMATION OF EMERGENCY IN THE CITY OF BROKEN ARROW BY CRAIG THURMOND, MAYOR OF THE CITY OF BROKEN ARROW

- **WHEREAS**, Chapter 20, Section 20.3 of the City of Broken Arrow Code of Ordinances and Title 21 Section 1321.1 *et al.* of the Oklahoma Statutes empowers the Mayor of the City of Broken Arrow to proclaim a state of emergency when the City of Broken Arrow is threatened by a local emergency that affects the life, health, property or the public peace of the City of Broken Arrow; and
- WHEREAS, on March 16, 2020, Craig Thurmond, the Mayor of the City of Broken Arrow found that conditions affecting public order, life, health, property or the public peace arose within the City of Broken Arrow due to the COVID-19 Pandemic and issued a Proclamation of Emergency prohibiting events of 50 people or more in City facilities; and
- WHEREAS, on March 19, 2020 Mayor Thurmond issued a second Proclamation of Emergency ordering the closing of certain business and commercial establishments either in-full, or with special conditions for limited operation, and other public accommodations shall remain in full force and effect; and
- **WHEREAS,** on March 31, 2020 Mayor Thurmond proclaimed an Amended Proclamation of Emergency due to the ongoing COVID-19 Pandemic, ordering all citizens in or visiting the City of Broken Arrow to shelter at their place of residence except for "Essential Activities"; and
- **WHEREAS**, on March 15, 2020, the Governor of the State of Oklahoma issued Executive Order 2020-07 declaring an emergency caused by the impending threat of COVID-19 to the people of this State and the public's peace, health and safety; and
- WHEREAS, on March 24, 2020, the Governor of the State of Oklahoma amended Executive Order 2020-07 requiring vulnerable individuals to stay home except for essential errands, closing non-essential businesses in counties with confirmed cases of COVID-19, suspending certain elective and minor medical procedures, prohibiting gatherings of 10 or more individuals and restricting visitation at nursing homes; and
- WHEREAS, on April 15, 202 Governor Stitt extended his Safer at Home order for vulnerable individuals until May 6, 2020; and
- WHEREAS, on April 22, 2020 Governor Stitt's Bounce Back Advisory group issued the Oklahoma Bounce Back Plan implementing a three phased approach to open Oklahoma's economy starting on April 24, 2020; and
- WHEREAS, Governor Stitt's Bounce Back Advisory group's Oklahoma Bounce Back Plan is based on scientific modeling from public health experts and is designed to mitigate the risk of the resurgence of COVID-19; and
- **WHEREAS**, Governor Stitt's Bounce Back Plan provides a detailed plan for the reopening of Oklahoma's economy that the City of Broken Arrow desires to implement and that no longer requires the City of Broken Arrow's separate local declaration of emergencies.

NOW THEREFORE IT IS HEREBY PROCLAIMED that the Emergency Proclamation issued on March 16, 2020, March 19, 2020 and Amended Proclamation of Emergency issued on March 31, 2020 are terminated effective Thursday, April 23, 2020 at 11:59 p.m.
