Honorable Mayor and City Councilmembers,


I hope you enjoy this first edition of the monthly City Manager's Report, our newest transparency tool. Within these pages you will find short yet informative updates from each of our respective city departments.

Solid Waste

- In 2020, the same two months collection of waste was 11% higher (likely due to the pandemic lockdown)



Recycling

- In 2020 BA had a great start to a new program with 1391 tons of recycling being diverted away from WTE/Landfill.
- In 2021 BA was well on its way to a 5,000-ton year of recycling diversion with 1,174 tons prior to the unfortunate fire incident at TRT (Tulsa Recycle and Transfer Facility).
- SW&R continues to work with our partners with the City of Tulsa, The M.e.t., Closed Loop, and TRT to re-establish our recycling program with a brand-new high-tech Material Recovery Center (MRF).



We are asking citizens to continue to use their blue cart the same as before. We will collect both and take it to the waste-to-energy facility. To continue to repurpose the material, the M.e.t. continues to take recyclables and is located at 302 N. Elm Place is open to the public M-S 9am to 5pm and Sunday from 1-5pm. If we keep the practice of recycling, we will be ready to get right back to business as soon as the facility comes back online.
