Route optimization, with the help of our great team of drivers and helpers, has seen an overall reduction in customer wait times for the department. Solid Waste and Recycling is also very proud to say we have reached our full complement of 26 drivers this month. Setting performance measures for the routes, being at full staff, and route optimization are just parts of an overall plan to help meet customer needs. Another way COBA can help is by reminding the public to get those containers at the curb prior to 7am! Don't wait till you see or hear the truck, by then it may already be too late.

- The Fall Free Dump Event will be held at the Waste Management Quarry 13720 E. 46th ST North, Phone number to landfill 918-439-7835 (opt2) 918-437-7773, on October 30, from 7am to 4pm. Broken Arrow residents may dump free presenting a driver's license with a Broken Arrow address or a recent utility bill. City employees will be on site to verify residency. Any household waste can be dropped off *except for the following items*:
 - Hazardous materials
 - Liquids (such as paint in liquid form, gasoline, oil, etc.)
 - Batteries
 - Fluorescent light bulbs
 - · Untreated medical waste
 - Compressed gas cylinders
 - Refrigerators/air conditioners/freezers/or Freon containing items will be accepted with the proper documentation that the refrigerant has been properly removed by a licensed CFC technician.
 - There will be a \$2 dollar fee for each car tire, \$4 fee for each truck tire.
 - Motor oil, batteries, antifreeze, steel cans and scrap metal are accepted year-round at the Metropolitan Environmental Trust (M.e.t.) recycling facility located at: 302 North Elm Place.
 - The facility also accepts plastic bottles, glass bottles, newspaper, office paper, aluminum cans, cardboard, and paperboard.


