

Resurfacing Projects

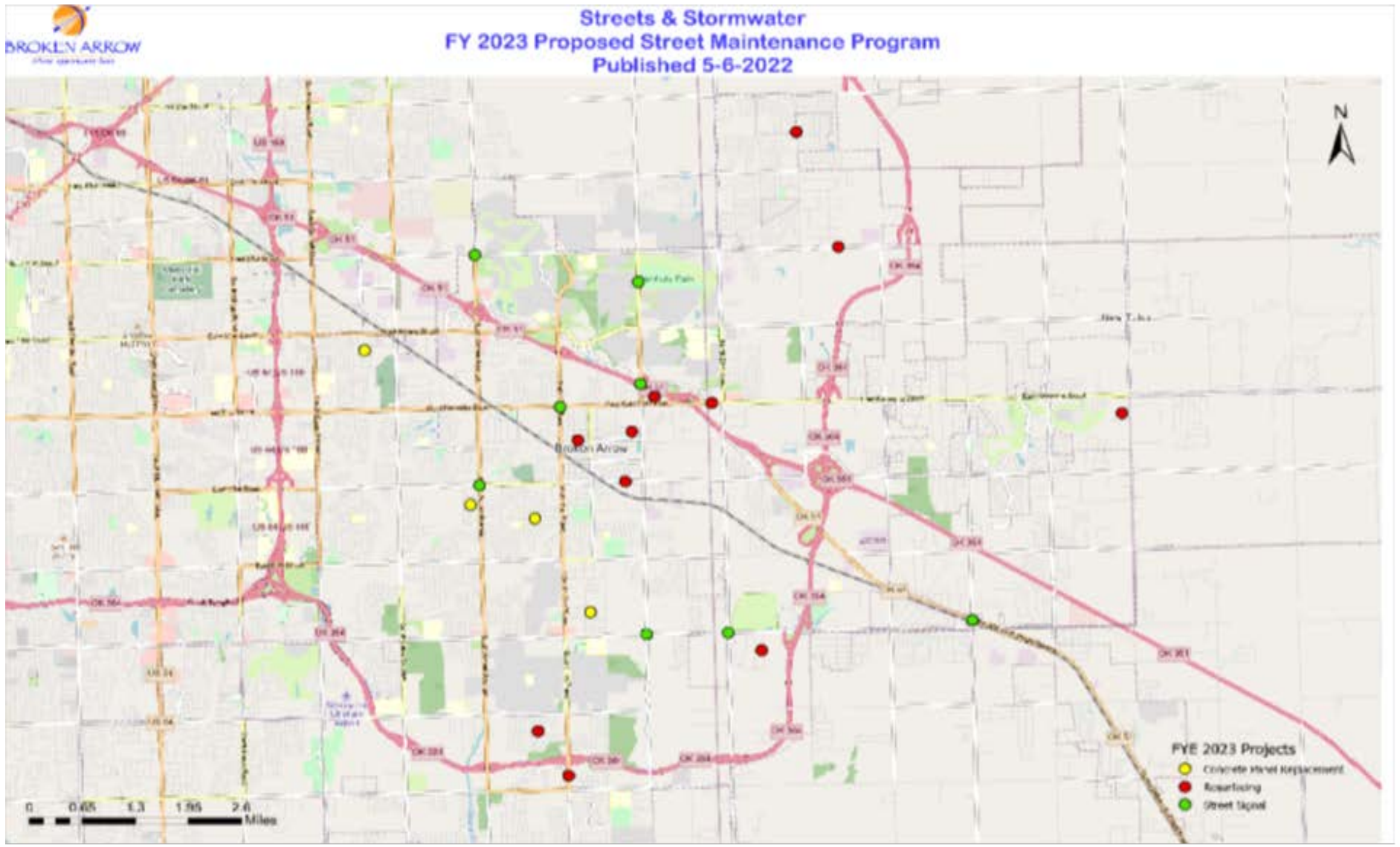
The process of resurfacing a street typically involves the removal of the existing 2-inches of pavement (milling). The surface layer under the asphalt, also known as agbase, is inspected to look for any base issues or failures that will affect the lifecycle of the pavement. If issues are found, the impacted areas are excavated and agbase (crushed rock) is installed and compacted to provide stability. After the base issue has been repaired, a tack oil is applied on top of the existing surface. This tack oil will help bind the asphalt to the existing surface and produce a durable yet flexible pavement.
