




After nearly three years of hard work, the City of Broken Arrow is fully live on all five systems and modules from Tyler Technologies.

#### **Key Projects**

Traffic Signals Inventory – The GIS Division launched a new application for Traffic Control. This application enables the Traffic Control Field crews to survey their signals, and record detailed information about signals, signs, controllers and other equipment. This application will allow Traffic Control to be more efficient and access their inventory information quickly.

Tyler Munis and EnerGov – With Tyler EnerGov going live last month, the City of Broken Arrow has reached an incredible milestone that is the culmination of nearly three years of intense effort. The Munis projects (known as Phases 1 through 4) represented four distinct Munis modules (Financials, Utility Billing, Human Capital Management, and Enterprise Asset Management) that had to be implemented across every City department. Tyler EnerGov (known as Phase 5) is the system that powers the Community Development department. While there are some small efforts still in progress in post-live production, these major projects are now complete.



August's IT Employee Spotlight is on David Ruiz. Dave is responsible for working Help Desk tickets and is also the main person ordering new computers when purchased for the City. Dave joined IT on February 29, 2016 which, because it is a leap year, means he has only been with IT about a (leap) year and a half.






