Fire Station Alerting Replacement

The Zetron alerting system in the older Fire Stations will be replaced with the newer Phoenix G2 alerting systems. This has always been the plan, but the execution of it is being accelerated. With the new Public Safety Enterprise Resource Planning (ERP) System, the original intent was to fully support the newer (Phoenix G2) systems in the new Fire Stations as well as support the legacy (Zetron) systems in the older Fire Stations. Having two alerting systems for Fire meant that Dispatch personnel would have to specifically know which station is which while learning a new system, which has proved quite difficult in reality. The IT Communications team will be working with the Fire Department to build this out and get implementation in place next month.

Water Plant upgrades

The first portion of equipment upgrades for the Water Plant has been received by the IT Network Systems team. The Water Plant utilizes Pall Scada controls, and this equipment is targeted to upgrade the SCADA system as well as the network and network architecture surrounding it. This will make our water and water utility more resilient as well as much more secure going forward. The implementation of the upgrade will proceed next month.

Server Cluster Storage Upgrade

With the City Council approval on November 1st, the upgrade project for the storage for our Tyler Technologies storage systems will begin with the Davenport Group assisting. This is an intricate and complex effort, as it will need to be done without interruption to City Departments and within key maintenance windows in order to keep the City running. All necessary equipment will be ordered this month with implementation tentatively starting next month once equipment is received.

Automatic Meter Reading/AMI Project

The equipment has been ordered to support this project with the Water department. It is expected that the network equipment won't arrive until later in the first quarter of 2023. Once it does arrive, the IT Communications team will be handling installation which will provide the outdoor wireless network that will help provide accessibility to the new meters.
