- Mover shall properly affix skid rails on top of all oversized loads
- Driver shall call BA Police 918-259-8400 one hour prior to move
- Your permit must remain in transport vehicle at all times during move & is subject to inspection by any law enforcement officer or City official.

Escort Costs: Size of load to be moved may dictate the need for Broken Arrow Police personnel to be involved in escort of load to ensure safety Of all persons and property involved. This requirement will be made at the discretion of City officials. Costs associated with the required escort from City of Broken Arrow Police Department personnel or departments may be charged to the Mover per hour, per employee, with a two-hour minimum. Arrangements shall be made with the City of Broken Arrow Police Department 48 hours prior to projected move date and time. City of Broken Arrow Police personnel or other will raise only lines that belong to the City of Broken Arrow. Transporting firm will be responsible for retaining qualified personnel to raise all utility lines.

Additional Charges: The City of Broken Arrow may, at their discretion, invoke upon the Mover any charge incurred for repair or replacement Of any damaged City property (i.e. traffic signs, signals, pavement, etc.) or any costs associated with unanticipated assignment of City personnel to assist with the move and/or escort of the oversized load per hour, per employee.

Marking Required: Mover is required to temporarily mark any roadside object, such as traffic control signs, devices, mailboxes, utility poles, etc., that are in any way moved, removed, struck or otherwise tampered with by Mover or their employees. Mover is required to reset these devices to their original position and condition, and is required to mark these devices by tying contractor's tape to devices to allow for later inspection.
