


COMMUNICATION TEAM SUPPORTS DISPATCH

The Communications team supported the 911 Dispatch Center in updating their call recorder server. All the calls that come through the 911 dispatch center and all traffic that goes across the radio network to talk to first responders are stored in a server. Radio traffic is encrypted with a unique key that enhances public safety and security. When the call recorder server needs to be updated, the new encryption key must be manually loaded into the server to decode this traffic. Dispatch managers can then review these calls and radio traffic when needed.



GIS COLLABORATION

The network infrastructure upgrade at the Public Safety Complex Data Center has replaced outdated End of Life and End of Support equipment, significantly enhancing network reliability, redundancy, and performance. The project was completed in four phases: replacing the Cisco ASA 5525 firewall with Fortinet 201Fs for improved security and redundancy; upgrading eight Cisco 2960S switches to 9300L switches at the access layer for better connectivity; replacing the Cisco 4510 with stacked Cisco 9500 switches for core routing and adding Cisco 9332 switches for distribution to enhance redundancy and bandwidth; and finally, upgrading Dell PowerConnect switches to Cisco



Nexus 93108 switches, doubling bandwidth to 200Gig speeds. These upgrades ensure a modern, robust, and highly redundant network infrastructure, supporting critical public safety and city services efficiently and reliably.

NETWORK INFRASTRUCTURE UPGRADE

The GIS team collaborated with the Water Quality department to improve the efficacy of their grease trap inspection program. By integrating ESRI web-based applications with data from Tyler Energov, the GIS team developed a custom live dashboard. This solution allows the Water Quality Department to promptly identify new businesses requiring inspection upon obtaining a business license from the city. Since this department already had an existing HUB-site hosting GIS applications, this solution was easily added to their existing platform. Prior to this development, there was no straightforward way for the Water Quality department to be notified of new businesses that needed to be inspected.


