CITY MANAGER'S WELCOME

Honorable Mayor Wimpee and Councilmembers,

I laughed out loud the other day when I saw a social media post that said the months of the year have gone by like this: Januuuuuuuuury, Februuuuuuuuury, Maaaaaaaaarch, AprilMayJuneJuly, August. LOL! I disagree, though. Last month continued the trend of us staying busy serving the citizens of Broken Arrow and I can honestly say January, February, March, April, May, June, July, and August is a better reflection of our year! Although, I will admit each month has gone by quickly. Here is a snapshot of what happened during the eighth month of 2024.

Reasor's grand opening. How exciting was it to see the return of Reasor's to south Broken Arrow! The store is one part of our plan to attract more economic development and ensure residents have access to businesses regardless of where they live in our great city.

Quarterly Work Session. Thank you for making time for this special meeting to publicly discuss the grain elevator, Elam Park master plan, and a long-term sanitary sewer system plan. It was a productive brainstorming session, which did not require any formal action from you, that provided paths forward for these important items.

Approval of the Oklahoma Water Resources Board loan. Thank you for your approval of this loan of up to \$21.45 million which will help fund various phases of 21 water utilities capital improvement projects this fiscal year.

Leadership Broken Arrow Class of 2025. The most recent class of city employees and one city councilor (looking at you, Councilor Green!), kicked off its 10-month leadership development training through the program hosted by the Broken Arrow Chamber of Commerce.

Results of the roadway improvements micro-survey. More than 3,000 citizens responded to this survey and provided us with valuable insight about which potential capital improvement projects they would like to be considered for the transportation proposition of the 2026 General Obligation Bond Election. The results are on the city website.

Oklahoma Turnpike Authority approves on-ramp connection in Events Park. Another great example of the state seeing the opportunity the amphitheater creates for citizens and visitors of Broken Arrow for the city and region. This connection will ensure there will be four points of egress for visitors to choose as they exit Events Park and the amphitheater.

Metronet internet services come to BA. In the comprehensive survey that was open to the public earlier this year, citizens indicated access to reliable internet services was an opportunity for growth in BA. Metronet is new to Oklahoma and making a \$35-million-dollar investment in our community to deliver high-speed internet to homes and businesses.

As I said, that is just a snapshot, but our Department Directors share the bigger picture in this monthly report about how our amazing city employees continue to outdo themselves to provide exemplary customer service and maintain the quality of life we enjoy in Broken Arrow!

I would be remiss if I didn't mention the start of the new school year. Here's hoping this is the best year yet for the students, teachers, support staff, and administrators at all schools in BA!

I look forward to seeing you at your meetings in September, and around Broken Arrow, the city where opportunity lives!





Due to the critical nature of providing zero downtime to public safety, many redundancies have been implemented to ensure 100% reliability in the radio network.



On August 9, the recycling team along with OKRA members went to Atoka, Oklahoma to visit the Green Li-ion facility to learn about commercial battery recycling. Green Li-ion is a lithium-ion battery recycling technology company producing modular hardware solutions that convert spent batteries into cathode and anode material that's ready to drop into manufacturing processes for batteries of all types. This is the

first of its kind and it is right here in Oklahoma.

The SW&R Leadership team has been working through some integration issues with the Routeware team to better refine our routes and upgrade our antiquated (or in many cases) non-operational hardware. The team, working with IT, Utility Billing, and our vendor has been able to make significant changes to the routing software that will enable us to provide even better customer service (as if that was possible). Our wait times for calls have reduced and go backs are leveled out. We have even circled back to some fixes we hope to be rolling out this coming year which will significantly increase positive customer outcomes. Special thanks to the team here and the external stakeholders who have been instrumental to our success.

MONTHLY HIGHLIGHTS

The Crisis Team took three suicidal subjects into protective custody and placed them into Crisis Care.

- Victim's Advocate spoke with 16 victims over the phone and attempted contact with an additional 11 victims; 9 were referred to services
- The Crisis Response Team have been working on helping a homeless person at Seiling Park. Over the past year, officers have responded to over 38 welfare checks on the individual. Officers Tyson and Wood arranged for a free tow from Allied Wrecker to move her vehicle to Precision Auto where they are currently doing an estimate. GMH has agreed to pay for the repair's dependent on the cost and a temporary hotel accommodation was obtained for her from Catholic Charities.
- Ofc. McNelley responded to a larceny in progress, LPR cameras at the location hit on a vehicle that had done several larcenies in the area. Male suspect selected several items and attempted to flee. He ditched the merchandise on seeing an employee and was contacted by officers. The suspect initially misrepresented to the officers and was found to have a felony and misdemeanor warrant out of Tulsa, additionally was found in possession of meth and paraphernalia.
