Re: Development Services Report – APA Conference and Stoney Creek

1. APA Conference Presentation Highlight - The American Planning Association (APA) is having its Annual National Planning Conference (NPC18) in New Orleans from April 21 through 24. This national conference is usually attended by more than 8,000 Planners, Planning Commissioner's, City Councilors, Architects, Designers and other elected and appointed officials and students.

Farhad Daroga, Special Projects Manager has been invited to be a speaker on a Panel – Educational Session (75 minutes), regarding Comprehensive Plans on Monday April 23, at 10:15 am. This is considered a prime time slot. The title/topic is FLUMMOXED by FLUMs (Future Land Use Maps) and the LUIS System (Land Use Intensity).

The City's/Panelists for this Session are City of Reno, City of Baton Rouge and Baton Rouge Planning Commission, City of Broken Arrow, City of Oklahoma City and Clarion Associates/Consultants.

The presentation and discussion will be regarding Comprehensive Plans, Plan Maps, Techniques of Land Use, Future growth, etc., and how big and small Cities are handling the implementation of their Comprehensive Plans. Oklahoma City recently won the prestigious Burnham award for best plan.

Attached is a short version of the power point Farhad will be presenting, as part of the larger presentation and discussion, along with the other cities.

We hope and plan to submit our comprehensive plan in 2020 for the Burnham award.

2. Stoney Creek Hotel and Conference Center – The Stoney Creek Hotel and Conference Center (SCHC) construction began in March 2015. Vision Funding was utilized for this project in the amount of \$7,110,834. The City and SCHC entered into an economic agreement in November 2014 for \$5,550,000 in various site improvements.

The construction began in March 2015. There were 5 major contracts for earth change, utilities, site work and landscaping. The construction reached major completion in late 2017 with a soft opening in early December and grand opening in January 2018.

## Development Services Weekly Report April 20, 2018

All of the contracted money was utilized for the project. Of the total vision money, approximately \$45,500 remains.

Since the soft opening they have been operating under a Provisional Certificate of Occupancy. This allows them to operate while completing a list of non-life safety items internal and/or external. To date, all items have been completed except for 2 fire hydrants needing rotated. SCHC expects to have these completed next week. A full Certificate of Occupancy will be issued at that time.


This was an amazing project to be involved in for the City and is and will be an asset and draw for the City.







The Comprehensive Plan for Broken Arrow, Oklahoma






1997:45 square miles33,000 parcels

# **Broken Arrow's LUIS Plan**

- In place for 20 years (1997)
- •Update process
  - Initially 2X per year
  - Since 2001: 4X per year
  - Same as Zoning hearing. Quarterly change dates approved each December
  - Implementation



# **Pros and cons**

- Very prescriptive and transparent
- Adopted policy requires Planning Comm. and City Council to follow plan (Have for 20+ years)

# City to present pre-final GO Bond package list; seeks final public input

Public meeting scheduled for April 23 at Stoney Creek

**Broken Arrow, Okla.** (4/9/2018) – The City of Broken Arrow will hold the next public meeting at 6 p.m., Monday, April 23, at Stoney Creek Conference Center, 200 W. Albany St., regarding the Build Our Future BA General Obligation (GO) Bond package.

This is an important meeting for residents to attend before Council approves the final package in May. Voters will later decide on the bond package August 28, 2018.

The City previously held three public meetings in February to learn residents' priorities for proposed projects totaling nearly \$280 million. In order to keep the ad valorem (property) tax rate the same, the City must bring the final package down to around \$210 million.

"There were some very difficult decisions to make to reduce the proposed project list," said City Manager Michael Spurgeon. "Without a doubt, every project on that preliminary list deserved to be on there because the investments made to infrastructure have a direct effect on the economy and quality of life in our community. Thanks to the feedback we received in February, both at the public meetings and by residents directly contacting the City and the Council, we were able to identify many projects that are a major priority for the people that live in Broken Arrow."

A total of 94 projects remain on the pre-final list, including:

- Widen Houston (81st) St from Garnett to Aspen
- Widen 23<sup>rd</sup> St (County Line) from Omaha (51<sup>st</sup>) to Albany (61<sup>st</sup>) St
- Improve intersections at 9<sup>th</sup> St (Lynn Lane)
