## Speed limits reduced on three Broken Arrow roads

**Broken Arrow, Okla.** (10/18/2018) – The City of Broken Arrow has reduced the speed limit on three roads in the southern portion of the City. Each road has been reduced to a 40 miles per hour limit, down from the previous 50 miles per hour limit.

Effective immediately, the speed limit reductions affect:

- Jasper (131st) Street between Olive (129th) Avenue and Aspen (145th) Avenue,
- Tucson (121st) Street between Olive Avenue and Garnett Road, and
- Aspen Avenue between Jasper and Tucson Streets.

These streets kept the Tulsa County speed limit of 50 miles per hour when they were originally annexed into the City. However, the City Council and City staff have heard from residents who feel that speed limit will be too fast with residential and commercial development currently underway and planned for the near future.

As a result, City staff decided lowering the speed limit on these roads was a reasonable safety measure. The City's Streets Department has already started replacing speed limit signs and will have all new signs posted by the end of the week.

## Community play date celebrates new Events Park playground

Broken Arrow, Okla. (10/11/2018) – The City of Broken Arrow will host a community play date to celebrate the opening of a new playground at the City's Events Park.

The Events Park has held several large festivals and events, such as the recent ScotFest, but the large park in southeast Broken Arrow lacked a playground for many years. The new playground features various climbing equipment and a rock wall with slides, three picnic pavilions, as well as a new restroom facility (SEE VIDEO). Construction cost about \$520,000, funded by the voterapproved 2014 General Obligation Bond.

Everyone is invited to join the community playdate, which begins with a ribbon cutting at 5 p.m., Thursday, Oct. 25, at the playground on the east side of the Events Park, 21101 E. 101st St. Light refreshments will be served. The entrance to the playground is east of the main entrance to the park, near 215th East Avenue.
