TRAFFIC SIGNALS & SIGNS

A number of projects have been completed to date this FY to upgrade the traffic signal system. These projects include the complete installation of the Liberty Trails flashing signal light at New Orleans St. (New Orleans/Creek Turnpike), project TS1903 (Ward 3). This division has also completed the installation and upgrade of control cabinets for the traffic signal system at the following intersections:

Upgraded Control Cabinet Locations-ST1904, ST1905, ST1906 & ST1907

- S 177th Ave and E Lansing St.(Ward 4)
- S 177th Ave and Hillside Dr. (Ward 4)
- Elm Place and Expressway Dr. (Ward 4)
- Elm Place and StoneWood (Ward 4)

Traffic Signs and Signals personnel have been completing routine maintenance on the city's tornado sirens, traffic signal light systems, pedestrian crosswalk signals, and replaced faded or damaged street signs.

STORMWATER DIVISION

The following projects were completed to date this FY to alleviate excess ponding water and to upgrade or make stormwater improvements to address various drainage issues.

Dallas and Hymas Project-SW1809 (Ward 2)

The addition of a storm drain and inlet to the existing stormwater system will help eliminate excess water from ponding on the property adjacent to the city's right of way.

9th Street Culvert Project-SW1811 (Ward 3)

A new RCB culvert has been constructed at 9th St. between Natchez Ave. and Jasper St. to replace the existing 36-inch pipe. This upgraded stormwater improvement will allow the structure to handle the additional capacity of water experienced during a significant rain event.

3rd Street and Jackson Bridge Project-SW1907 (Ward 4)

A new RCB bridge was constructed at S 3rd St. from E Mason Dr. to E Jackson St. This upgraded stormwater improvement will allow the structure to handle the additional capacity of water experienced during a significant rain event.

Morrow Ridge-Channel Bank Reinforcement Project-SW1810 (Ward 1)

This project on N 9th St. from Albany St. to Jasper St. consisted of leveling the existing grade, and the installation of new sod to address erosion control issues.

Bel Lago – Downstream Improvement Project-SW1808 (Ward 1)

This project on Evans Rd. from E 78th St. to E 76th St. S required the division to add a storm pipe to the inlet in order to lower the elevation of the flow line to the detention pond. This improvement will eliminate standing water.

Snow and Ice Control

The Streets and Storm Water department responded to the snow event that occurred on November 12, 2018. Starting at 6 am, the department dispersed an on call crew of seven individuals, using 65 personnel hours and 72 tons of salt to pre-treat the bridges, streets with a grade in excess of 10%, and snow routes 1-6. Once completed, they proceeded to maintain and treat slick spots, as well as, respond to calls from the Police Department.

Snow and Ice Removal Meeting

The Streets and Stormwater department held a Snow and Ice Control coordination meeting on November 16, 2018. This meeting covered topics such as snow route priorities, winter operations policy, shift assignments and expectations. City personnel was given specific guidance on what is required, in order to ensure safety for themselves as well as the traveling public.

Mayor attends White House housing discussion

This is the Mayor's fourth White House invitation in 2018

Broken Arrow, Okla. (11/16/2018) – Broken Arrow Mayor Craig Thurmond has been invited to the White House for the fourth time in 2018. Thurmond will attend the White House Roundtable on Housing Affordability on Friday, Nov. 16.

The purpose of the housing roundtable is to gather input from local government leaders and discuss the unique challenges faced by municipalities. Housing and Urban Development Secretary Ben Carson, as well as other key officials, will speak during the event.

"Once again, I am honored to receive an invitation to an important White House meeting to discuss matters of great importance to the country," Thurmond said. "I look forward to sharing the thoughts of Broken Arrow residents and Oklahomans with members of the Housing and Urban Development Department as well as White House staff."

This is Thurmond's fourth invitation to the White House this year. He was previously invited as a select group of U.S. mayors to attend Mayors' Day at the White House: A Conversation with President Trump in January where President Donald Trump announced plans to spend \$1.7 trillion on infrastructure.

The mayor was invited to attend the Mayor's Infrastructure Discussion in March, where a select group of mayors met with D.J. Gribbin, Special Assistant to the President for Infrastructure. Thurmond also attended the White House Conference with Oklahoma Local and County Leaders in August.

City Plan Development Manager Larry Curtis will accompany the Mayor to the roundtable.
