Fire Academy Adds 19 New Firefighters to BAFD

Graduation ceremony this Friday

Broken Arrow, Okla. (6/22/17) – The Broken Arrow Fire Department (BAFD) will hold a graduation ceremony for 19 new firefighters this Friday, June 23, at 2:00 p.m. at Northeastern State University in Broken Arrow, 3100 E. New Orleans Street.

With the addition of these new firefighters, BAFD has fulfilled a Vision 2025 Renewal campaign promise to hire 20 new firefighters by 2020. Broken Arrow voters in November 2015 agreed to renew the Tulsa County Vision 2025 sales tax and repurpose it to pay for additional police officers, firefighters and local street improvements. Nine new firefighters were hired back in November 2015, and now 19 additional firefighters will join the department.

BAFD's authorized strength is currently at 173.

"We are extremely thankful for back to back FEMA grants, which allowed us to reach our staffing goal in less than two years. The renewal of the vision sales tax allows us to retain firefighters after the grants expire," said Fire Chief Jeremy Moore. "More importantly, these additional firefighters will help make our community safer everyday by providing more trained personnel on emergency scenes."

TCC INTERNS ALSO GRADUATE

This graduating class also includes five students from Tulsa Community College (TCC), who took part in the Fire Academy for the first time as part of a partnership between BAFD and TCC. The BAFD-TCC partnership allowed TCC students to intern at BAFD and train side by side with cadets in the Fire Academy.

Fireworks Permits Available now through July 3

Must have permit to discharge fireworks within Broken Arrow City limits

Broken Arrow, Okla. (6/20/2017) – Residents of Broken Arrow who would like to legally discharge fireworks in the City limits may do so by purchasing a fireworks permit for \$21. Permits are available for purchase online through July 3. In-person permit purchases must be made before City Hall closes at 5:00 p.m. on Monday, July 3.

Applicants for permits must be 18 years of age to apply for and obtain permits. Permits may be applied for online at www.brokenarrowok.gov/fireworks 24 hours a day, 7 days a week. Permits may also be purchased in person at Broken Arrow City Hall, One Stop Center (north end of City Hall) 220 S. First Street. Permits will not be issued to persons under 18 years of age. It is unlawful to discharge fireworks within City limits without a permit. Certain restrictions apply.

Permits are valid during the hours of 3:00 p.m. -11:00 p.m. July 3 and 4 only. There are also special notes and comments listed on the printed permit. A printed permit is required on the premises where the fireworks are discharged.

Fireworks debris must be extinguished and disposed of properly, by placing inside trash bags. Large boxes may be placed next to trash bags. Failure to do so may result in fines of \$225.00 plus cost.

Fireworks must be discharged on a noncombustible surface of sufficient size to contain the entire ground portion of the display, not closer than 25 feet to any permanent structure.

Local volleyball club to represent USA and Broken Arrow overseas

Madison Swift thought she was in trouble when her parents barged into her room.

"My dad, he goes into my room and says, 'We have something to tell you,'" Swift said. "I thought, 'Oh, what'd I do. I'm in trouble.'"

Swift prepared for a punishment. Instead of being grounded for a week, Swift was told she would spend that time of her summer in Europe.

"I just said, 'I don't believe you,'" Swift recalled.

Swift's teammates had similar responses of disbelief.

Broken Arrow Volleyball Club, founded and directed by Janet Tyler, will compete in the United World Games on June 23-25 in Austria. The team, which features nine girls from the Tulsa area, will be the only 15-and-under girls club representing the United States in the event. Most teams competing at the United World Games are comprised of athletes from various locations.

"That's unusual for this type of thing," Tyler said. "Usually, it's spread out. Usually, it's kids from all over and different states. This is the first time that they've had an entire club get an entire team together and go over. It's kind of a big deal at the moment for them."

The United World Games is an annual international competition that Tyler described as an Olympics for younger competitors. The event features more than 400 teams from more than 40 countries and 11 sports. Every team is guaranteed five games between pool play and bracket play in the volleyball competition. An opening ceremony in the players' village is Friday.

The week starts with sightseeing trips to Germany and Italy before competition starts in Austria that weekend.

"They give the kids an opportunity to be able to experience cultures," Tyler said. "(They're) not just going over and just playing, then coming back. They're going over and taking advantage to learn a little bit."

Each girl was chosen to do more than just play volleyball. Athletes are chosen by Student Athlete World to represent the U.S. based on competitors' performances and characters off the court. While a video of their skills on the court was required during the application process, each participant also had to submit a letter of recommendation to prove they are solid students in the classroom and possess leadership ability.

"These are kids that had to excel," Tyler said. "These weren't kids that were just going to pay the money and go.

"They made sure these are kids that are going to represent USA in a positive light."

Economic Development Grants

I would like to take this opportunity to update you on recent economic development grant awards.

One of the Broken Arrow Economic Development Corporation's responsibilities is to connect businesses/industry to government grants and programs. Each year, EDC staff (Kinnee) makes around 100 BRE (business retention and expansion) visits to BA manufacturers and similar. During these visits, she routinely assesses opportunities to connect them to grants and other government (primarily state, but also some federal) assistance. If she identifies an opportunity, she connects them with the appropriate agency and facilitates the application process.

Over the past few years, several of Broken Arrow industries have benefited from Oklahoma Center for the Advancement of Science and Technology (OCAST) grants. OCAST is a state funded agency under the Department of Commerce and it has a pool of funds available each year that are used as matching funds to stimulate workforce development and research and development. These are 50/50 matching grants with the business paying half. These create more jobs and new processes and products.

Without the support of Kinnee/EDC and the connection with OCAST, Broken Arrow businesses would not be getting these grants. BAEDC Staff, often go to the universities and find professors to work with them to write grants. Yesterday, it was announced that three (3) BA companies were recipients of grants:

Total Valve received an Oklahoma Applied Research Support grant in the amount of \$300,000. They match the grant with another \$300,000 to have \$600,000 in product development.

Flight Safety received \$30,000 with which they match \$30,000. This funds two interns at 1000 hours each. This is the second year that Flight Safety has received the matching grant funds

OSECO received \$30,000 with which they match \$30,000. This funds two interns at 1000 hours each. This is OSECO's first grant. OSECO is UK-owned and they are making significant investment in BA.

The past two years, tactical electronics has received \$30,000 for internships (total of \$60,000).

Of note, Dover Artificial Lift was approved to receive a \$300,000 OARS grant like Total Valve. However, due to legislative state funding cuts, there was no money to give them. They have selected BA as their regional HQ (announcement coming soon) in part because of the support we have provided them.

This is great news for our community and I'd like to thank Kinnee and the EDC for their efforts. Please feel free to pass this good news along to the City Council.
