Dear Local Franchising Authority,

I am writing to inform you of a customer equipment change that will affect someone in your community. Cox will soon be migrating select channels to a new technology platform called Switched Digital Video (SDV). SDV technology allows Cox to maximize its network capacity, enabling us to offer even more high-definition channels and entertainment options to our customers.

Similar to other advanced services we offer, such as On DEMAND and the Interactive Programming Guide that require two-way communication between devices to access the services, customers will need a device capable of two-way communication to access SDV channels. We will notify Cox customers who own at least one device that is only capable of one-way communication, commonly referred to as Digital Cable Ready (DCR) devices. If a customer owns a DCR device, they have a couple of options they may choose from that will allow them to continue to receive all of the channels they currently enjoy.

First, if a customer owns one of the devices listed below, Cox is able to provide them with a Tuning Adapter free of charge that will allow them to continue receiving all of their existing channels with their device. This adapter will make their device compatible with the SDV platform. Tuning Adapters are currently available for the following devices:

- Tivo (Series 3, Tivo HD and HD XL, Tivo Premiere, Premiere XL and Premier Elite)
- Moxi HD DVR
- Windows Media Center OCUR
- Ceton InfrinitiTV-4 and InfrinitiTV-6
- HD HomeRun Prime

Tuning Adapters are easy to install and self-installation kits and tuning adapters can be picked-up at a local Cox retail center. For the customer's convenience, we will include a list of Cox retail locations in the notification letter.

If the customer's DCR device is not listed above, it may not be compatible with the Tuning Adapter. As an alternative for continued access to the switched channels, Cox can offer these customers, for lease, a digital or high-definition receiver. These receivers enable access to the channels listed on the back of this page as well as other two-way services including On DEMAND and the Interactive Program Guide. Cox will offer either receiver for the same price as a CableCARD for 12 months at \$1.99 a month. Customers can refer to **special offer code CBLCARSDV.***

If a customer does not request a free Tuning Adapter, or lease a receiver, they will not be able to view the switched channels with their one-way DCR device on or after August 10th, 2017. There are approximately 110 customers in the Cox coverage area surrounding Tulsa with CableCARD technology to which this letter refers.

Opening of New Turf Football Fields Marks Milestone for City of Broken Arrow

Broken Arrow, Okla. (7/12/17) – On Friday, July 14, the City of Broken Arrow, along with the Broken Arrow Youth Football Association, will celebrate the opening of two new artificial turf fields at the Nienhuis Football Complex, 3201 N. 9th Street. Broken Arrow voters approved construction of the turf fields as part of the 2014 General Obligation bond package. The cost to install the artificial turf was \$1.2 million. BA Youth Football contributed \$50,000. Football and lacrosse teams plan to utilize the fields year-round.

“It’s rare to find city-owned turf playing fields for leagues to play on, so we’re thrilled that the voters of Broken Arrow supported a financing package to convert grass fields into artificial turf for our kids,” said Chad Lott, President of the Broken Arrow Youth Football Association.

The new turf fields provide many advantages over regular grass fields, which can wear out over time and have to continually be maintained. Turf fields allow for almost unlimited usage, and heavy rainfall does not impact field conditions.

“The accessibility of youth sports is what draws many families to live in Broken Arrow,” said Parks and Recreation Director Scott Esmond. “These new turf fields will take the football and lacrosse experience to a whole new level, and the City is proud to partner with BA Youth Football to make this happen.”

Labor Study Role Out, June 29

One of the pressing issues our division discovered is the need for detailed local information on the labor market that our subscription services and labor data sources don't cover. Site Selection Group out of Dallas, Texas was selected to conduct a Workforce Availability Study and Wage Analysis for the 11 county region. The study cost \$80,000 and took more than 16 weeks to complete. A press event was held on June 29 covering the study's results including key components of the assessment: a review of commute times; underemployment; the workforce pipeline and future demand; education and industry gap analysis; and wage and benefits. Employer results were very good with 101 firms surveyed covering more than 36,100 workers in the region with an emphasis on manufacturing.

We had nearly 20 regional partners attend a meeting to hear Chris Schwinden's presentation on the survey and why such efforts are important to economic development as well as attend the press conference. The final report should be available at the end of July.

Governor's Economic Development Marketing Team "GEDMT" Annual Retreat, June 29-30

We hosted the annual Governor's Economic Development Marketing Team retreat June 29 and 30 with numerous programs and events including a detailed presentation from Chris Schwinden, Site Selection Group on the rollout of our 11-country labor assessment and how other communities can benefit from conducting their own regional studies. Other programs focused on FDI Trends and Strategies for Success, an Oklahoma Overview on Regional Efforts by Secretary of Commerce Deby Snodgrass and discussions on GEDMT Plan of Work for 2017-18.

Paris International AirShow, June 19-23

The Paris International Airshow was held June 19-23. The show was attended by more than 351,000 visitors from 50 countries. The objective of the Tulsa Regional Chamber for attending this airshow was

to seek new business connections and cultivate existing business relationships to foster growth in our regional aerospace and defense sectors, and to spotlight how the Tulsa region plays a vital role in Oklahoma's aerospace industry.

Tulsa's delegation included Kathy Taylor, representing Mayor Bynum, Dennis Altendorf and Brien Thorstenberg from the Tulsa Regional Chamber, representatives from other economic development organizations (Broken Arrow, Oklahoma City) and seven Oklahoma companies/organizations: The Tulsa Airport Authority, Mid-America Industrial Park (Pryor), M&M Manufacturing (Tulsa), Janeway Machine (Salpulpa), Ferra Aerospace (Grove), Consolidated Turbine Specialist (Bristow) and Autoquip (Guthrie).

Dennis Altendorf, Kathy Taylor and Brien Thorstenberg held private meetings with five company headquarters with existing operations in Tulsa, and 12 meetings with aerospace companies to discuss the possibility of opening a facility in the Tulsa region. Through these private meetings, four potential relocation projects were identified. They also traveled to Hamburg Germany to meet with Lufthansa Technik Component Services and Bizjet's corporate leadership to strengthen our relationship with the companies and identify potential growth opportunities.

International Economic Development Council (IEDC), Economic Future Forum, June 4-6, Little Rock, AR
 Tulsa Regional Chamber President/CEO and Project Manager of Economic Development attended the IEDC Future Forum. The theme of this year's conference was Transforming Your Community's Economy. This conference is attended by approximately 250 plus senior managers of economic development organizations and Certified Economic Developers (CEcDs). The conference provides ongoing training to ensure economic development professionals are equipped with the latest knowledge in emerging trends for a competitive business environment.
