Re: Development Services Report – Downtown Residential Overlay District

After considerable discussion and input from stakeholders and staff, the consulting team of ADG and Winter & Company have made some amendments to the Downtown Residential Overlay District (DROD) Design Standards.

The final draft is complete and staff have received support and compliments from citizens and stakeholders. The Broken Arrow Chamber of Commerce has written a letter officially endorsing this proposal as well as endorsement from the Greater Tulsa Area Homebuilders Association for this final project and change to the Zoning Ordinance.

The Downtown Advisory Board (DAB) reviewed this final version of the DROD document on Tuesday, November 14, 2017, and unanimously approved it and recommended its adoption.

The Planning Commission conducted a public hearing on Thursday, November 16, 2017. The Planning Commission approved this final proposal to the Zoning Ordinance and has recommended its approval.

The Planning Commission recommendation will be forwarded to the City Council for consideration on December 5, 2017, along with the recommendation that this proposed DROD Standards be approved and placed into effect starting January, 2018.

In 2015 the Broken Arrow Economic Development Corporation, in conjunction with our work with Rose District development, issued a white paper entitled Rose District 2.0. The EDC board endorsed and recommended that the city implement those items covered in the plan. One of those items was the recommendation that the city commission and implement a residential overlay district that increased density and laid out clear design standards.

Over the past year the EDC team has worked with city staff on this project. Our input and that of residents has been heard and incorporated in the proposed design standards.

City to Sell Surplus Equipment in Online Auction, Starting Nov. 27

Broken Arrow, Okla. (11/16/2017) – The City of Broken Arrow will hold an online surplus auction from Nov. 27-Dec. 11.

Bargain hunters interested in obtaining used cars, trucks, electronics and more can find a list of items for sale on the City's website at www.brokenarrowok.gov/auction.

Photos and details of the items will be available on the auction site itself upon start of the auction at 3 p.m. on Nov. 27. The auction website is www.publicsurplus.com/sms/brokenarrow.ok/list/current?orgid=49348

Interested bidders may view the items in person before placing a bid. Instructions for scheduling an appointment can be found with the item's detailed information on the auction website.

Once the online auction begins, bidders will have 10 working days to participate before the auction closes at 3 p.m., Dec. 11. Winning bidders must claim their items from the City's warehouse, 1700 W. Detroit St.

The surplus property and equipment has outlived its usefulness to the City. Because the estimated combined value of the items to be sold is in excess of \$15,000, it had to be declared surplus by the City Council.

Proceeds from the sale of surplus items will be deposited into the General Fund and Broken Arrow Municipal Authority (BAMA) funds, depending on the sold item's source funding.
