

2. City staff sampled the following facilities:
  - Blue Bell Creameries (Biochemical Oxygen Demand, Total Suspended Solids, and Oil & Grease)
  - Verdigris Water Treatment Plant (Citric Acid Waste)
3. The following reports/certifications were received and reviewed in the month of December:
  - Blue Bell compliance monitoring report and laboratory analysis
  - Blue Bell 24-hour spill notification for 12/24/15 (300-400 gal. ice cream mix)
  - Blue Bell 24-hour notification of permit non-compliance (oil and grease limit violation)
  - Broken Arrow Powder Coating (SW Expressway Dr.) compliance monitoring report and laboratory analysis
  - Unifirst compliance monitoring report and laboratory analysis

Surcharges for Bio-chemical Oxygen Demand (BOD), Total Suspended Solids (TSS), and Oil & Grease above residential thresholds were issued to Unifirst as a result of this analysis for \$1,923.40. Blue Bell surcharges were calculated but not issued. Utilities staff met with Blue Bell to discuss package pretreatment option. Surcharges have been deferred until an agreement is made.
4. Submitted amendment to annual pretreatment report to the DEQ for Lynn Lane Wastewater Treatment Plant Basin. Report stated that there were no violations, which was not correct. Amended report was submitted listing a zinc violation for Broken Arrow Powder Coating (809 N. 16<sup>th</sup>) in April of 2015. Back-up documentation was also submitted showing the notice of violation issued by the City and a re-test for zinc that was within permit limits.
5. City of Broken Arrow pretreatment staff facilitated DEQ pretreatment compliance inspections for Lynn Lane and Haikey Creek Wastewater Treatment Plants.
6. Submitted quarterly report of pretreatment activities in the Haikey Creek Wastewater Treatment Plant basin to Regional Metropolitan Utility Authority (RMUA).

## **Comprehensive Survey of Street Conditions Begins**

**Broken Arrow, Okla. (1/28/2016)** – An advanced assessment of street conditions is now underway in the City of Broken Arrow, as part of an effort to develop a multi-year road repair plan for the community. The renewal of the Vision 2025 sales tax greatly enhanced the City’s road maintenance budget, which is estimated to be \$3.3 million annually.

“This survey will give us an accurate depiction of the condition of our entire road system,” said Steve Arant, Director of Streets and Stormwater. “Not only will the final report be useful in maintaining the current status, but it will also allow us to devise a plan of action to improve overall road conditions.”

Over the next few weeks, citizens will notice a small white bus marked with the letters “IMS” slowly driving throughout the City. Infrastructure Management Services (IMS) will use a combination of lasers and digital cameras to capture the condition of streets. 622 miles will be surveyed. That information will be used to conduct a pavement condition analysis, which will examine predicted changes in pavement condition over time. Current conditions are compared with future conditions so the effects of maintenance activities can be evaluated.

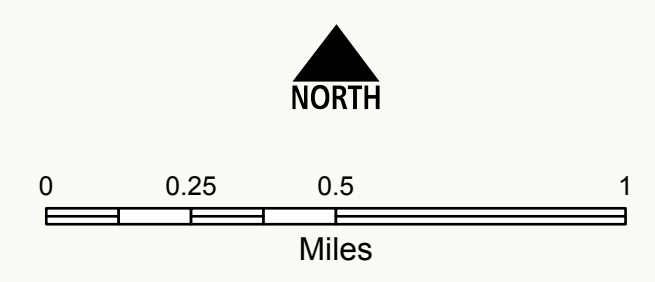
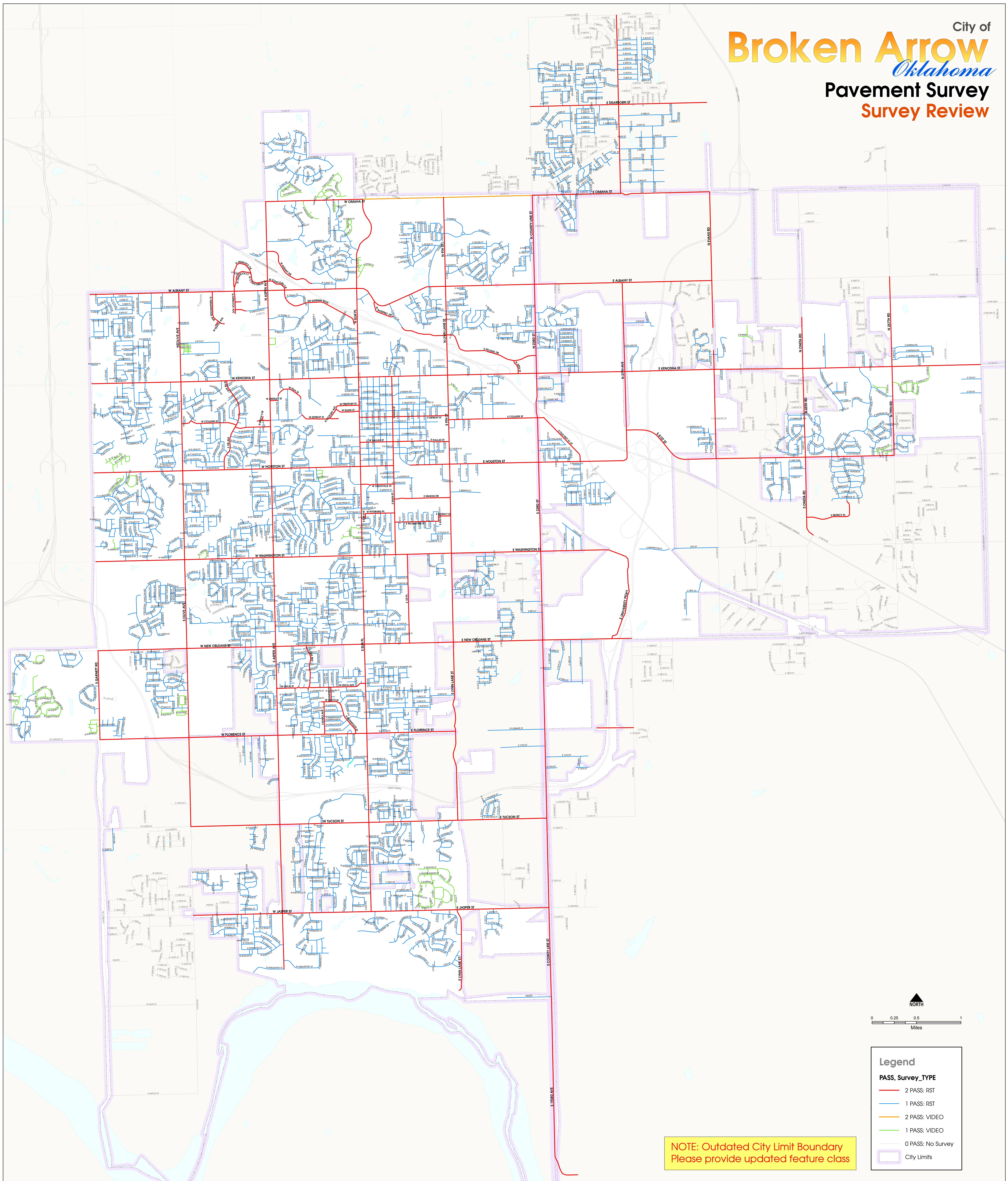
Upon completion of the survey, IMS will provide a database including sign inventory and condition, pavement condition, pavement analysis, and a comprehensive 5-year street improvement plan. Funding for the Pavement Management System is provided from the Sales Tax Capital Improvement account in the amount of \$292,199.

Pavement condition analysis is a common practice used to manage road maintenance planning throughout Oklahoma and the United States. Some cities that IMS has worked with include Bartlesville, Edmond, McAlester, Norman, and Stillwater.

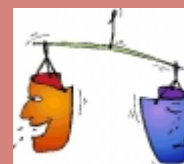

*Pride and Prejudice* is a faithful condensation of Jane Austen's comedy of manners. Set in England in the early 1900's, the plot centers around the five daughters of the Bennet family and their Mother's desperate fixation to find husbands and settled futures for them amidst the English upper-class.
