
Definitions

- **Priority 1 =** Crimes in progress involving life threatening circumstances and situations that produce or are likely to produce serious bodily injury or death to any person.
- Priority 2 = Crimes in progress or that have just occurred, incidents in progress that present the potential for injury or property damage/loss, situations where the suspect is still at the scene or in the area and will elude apprehension or create the potential for injury or property damage if the police do not arrive rapidly, incidents where an officer is needed to secure a scene or witnesses, and incidents where there is a need for crowd control or traffic control which, if not done immediately, would create the imminent potential for injury or property damage/loss.
- **Priority 3 =** Crimes against people that are misdemeanors in progress or that have just occurred, reports of recent felony crimes, suspicious circumstances with no threat of injury, and incidents that do not require an officer immediately, but need investigation, mediation, or intervention.
- Priority 4 = Property or service related calls for an officer to respond that cannot be handled by telephone, misdemeanor reports when caller demands officer or when an officer needs to investigate the scene or interview witnesses, and requests for officers that do not require a quick response.
- **Priority 5** = Primarily Officer initiated calls or ten codes used for in-house purposes.




If your water utility is interrupted, we recommend that an exterior faucet be turned on to release any sediment in the lines before utilizing any interior faucets.


Broken Arrow Warren Theatre, the luxury megaplex that opened last December, is warming up this season with a summer-movie kids series unlike any offered in the Tulsa area before.

This new program starting in June will offer children age 13 and under not only free movies, but also free concessions and free live entertainment at the theater.

Admission to these movies for those age 14 and older, including adults, will also be free.

"We think we've got the nicest theater in the state, and we want to encourage those people who haven't come out to see us to do so," said Bill Warren, owner of the 18-screen theater.

He built the \$43.5 million multiplex with the goal of it being "the nicest theater built in the U.S. in the last



Those accents have attracted adults, and now Warren is looking to draw children and their parents to see movies at his showplace.

The films, showing for 10 weeks at 10 a.m. on Tuesdays and Thursdays, are from recent years. They include hits like "The Lego Movie" and "How to Train Your Dragon," and all are rated PG. The movie program will also feature a free concessions combo-pack — a drink, a popcorn and a candy — available for those age 13 and younger.

In addition, plans call for a balloon artist and a costumed character to be on hand providing pre-movie entertainment.

"I think what we're offering is a better value for our guests," Warren said. "Free movies, concessions, entertainment — I think people are going to like that."

He said he's been pleased with the theater's performance in the Tulsa-area marketplace, "But we know there are still people out there who haven't tried us yet, so this just extends that invitation even more so.
