WalletHub Names Broken Arrow Best City for First Time Home Buyers

Broken Arrow, Okla. (8/19/2014) – Broken Arrow has been named the Best City for First-Time Home Buyers by personal finance website WalletHub.

To determine which housing markets most favor first-time home buyers, WalletHub assessed the affordability of homes as well as the conditions of the real estate market and community environment in the 300 largest U.S. cities. WalletHub used 17 key metrics, ranging from median house prices and real estate taxes to median home price appreciation and price-to-rent ratios.

"It's no surprise that out of the 300 largest cities in the U.S., Broken Arrow is the best city for first time home owners. You get a high value home for less than what you'd pay in other parts of the country," said Mayor Craig Thurmond. "Our low crime rate, excellent schools, availability of high-paying jobs and a wide variety of recreational and cultural amenities makes Broken Arrow an attractive place for people to buy their first house.

According to real estate database Zillow, the current median home value in Broken Arrow is \$146,500. Home values have gone up 6.0% over the past year and Zillow predicts they will rise 1.6% within the next year.

On June 10, 2014, the Department of Environmental Quality (DEQ) issued Broken Arrow Municipal Authority (Authority) Notice of Violation (NOV) No. S-20409-14-1 for violating the total dissolved solids (TDS) sampling requirements for December 2013 as outlined in the Authority's DEQ-issued OPDES Permit. On July 9, 2014, the Authority submitted a response to DEQ. The response stated that the Authority had determined that an operator error occurred in the sampling procedure and that the standard operating procedure (SOP) was reviewed and revised following the violation.

Upon review of the Authority's monthly discharge monitoring reports, DEQ believes that the actions taken by the Authority to eliminate and prevent future violations of this nature are adequate. Therefore, DEQ is closing NOV No. S-20409-14-1.

Battle Creek Golf Club – July Review



General

July we were able to achieve budgeted revenues for the month as weather conditions were a little cooler and weather than normal. Total revenues were \$176,263, which exceeded budgeted revenues by \$5,538. Total rounds for the month were 4,390, which exceeded budgeted rounds by 40. All revenue line items were relatively on budget except for merchandise sales of \$17,419, which was \$3,281 higher than budgeted merchandise sales.

Golf Operations

With the weather heating up, we have been consistently offering ice cold mango scented cold towels to all of our customers during their round of play. This adds a nice touch to the overall golf experience at Battle Creek GC. We also are still setting up the ice cold apple bin on the course during all weekend play, offering an ice cold apple to all players. Our summer Tournament Series Individual Match Play tournament is in full swing. With this single elimination tournament, all players schedule their matches and play on a preferred day that works for them.

Course Maintenance

July was warm as expected although we did have a few breaks in the heat this month. We did receive a total of 5.1 inches of rain this month.

The maintenance team did accomplish many tasks this month as well as our seasonal scheduled mowing's, these task include: Needle tining greens to improve air flow, spot spraying post-emergent weeds, sprayed fairways and tees with a growth regulator to help reduce clipping yields, sprayed wetting agents on tees, fairways and greens surrounds to help retain moisture in the soil, installed a drain by the tee boxes on hole 14, some sod patching on the course, sprayed greens with preventative rates of fungicide and insecticide, Irrigation repairs as needed, top-dressed greens lightly, aerified the back 9 tee boxes to improve water and air penetration. We also spent several man-hours a day hand watering greens when needed.

Next month we will continue our mowing schedules, continue to use wetting agents and plant growth regulators, needle tine greens, hand water greens as needed, aerify tee boxes, and high traffic areas on the course.

Bixby considering \$3 million master plan to update municipal buildings

Bixby considering \$3 million master plan to update municipal buildings By NOUR HABIB World Staff Writer | 0 comments

BIXBY — During a special work session with councilors last week, city staff presented a possible master plan for updates and improvements to Bixby's municipal buildings.

Offices for city staff are currently located at two adjacent buildings in downtown Bixby. City Hall houses the city manager's office, city council chambers, municipal court and police and fire departments. The Dawes Building houses the remaining city departments.

A recent bond issue made significant investments in City Hall, but all updates have been performed in a "piecemeal" manner, said city engineer Jared Cottle.

"Everything was done without a real plan for what we were going to do in the long term," he said.

The master plan, which Beck Design helped put together, will help make the two buildings more secure. The changes would also group departments by job function to minimize flow between the buildings.

"City Hall would maintain most of the functionality that it has today," Cottle said.

The Dawes Building would house departments that focus on public services so that most public interactions can occur there.

Other changes in the Dawes Building would include building a controlled access entrance, adding a new conference room, changing the roof and renovating the restrooms to make them ADA compliant. Improvements would also be made to the exterior of the building to give it a more modern look and make it a better fit for the downtown area.

Among the improvements at City Hall would be adding a conference room off the council chambers so that councilors do not have to leave the building to hold executive sessions. An atrium would also be added at the entrance to make the building more secure and to provide outside access to the courtroom.

Improvements on the outside of the property would include adding canopies for covered parking and covered walkways between the buildings.

To complete all projects on the master plan would cost the city about \$3 million. But about \$1 million worth of the projects are not an immediate need and could be postponed, Cottle said.

City manager Doug Enevoldsen said the city has been planning for the needed renovations and has some money set aside for the purpose from the capital improvement funds. But additional resources would be needed.

Councilor Dennis Loudermilk said he could see the need but preferred that the projects go to a bond election so that the public can vote on them.

"If we have that kind of money sitting around, I'd like to see some roads fixed," said Loudermilk, who added that it would be difficult to explain to constituents why their streets aren't fixed but city hall is getting improvements.

Enevoldsen said staff have been working on finding ongoing revenue to <u>fund the Citywide</u> <u>Infrast</u>ructure Rehabilitation Program.

Last week's presentation sought to get initial feedback on the plan from council.

"We clearly have needs, and this piecemeal thing we've been doing we know is not necessarily in our best interest," Enevoldsen said. "So we wanted to look ahead at what would make the most sense."

But he added that the city would not undertake the projects unless the council is fully comfortable with it.

Tulsa World Editorial: BA voters face eight tax issues Aug. 26

There's plenty for Broken Arrow city officials to be antsy about concerning a series of funding issues going before voters Aug. 26.

Broken Arrow City Hall has been unsettled. In July, the city council accepted City Manager Thom Moton's resignation on a 3-2 vote. Moton's employment had been the subject of a half-dozen closed-door council meetings, and the city ended up giving him a \$106,100 severance package.

That's not the optimum environment for taking a tax issue to voters.

The package could also suffer from its own complexity. A total of eight questions will face voters. There are five bond issues, including funding for streets, public safety, parks, public buildings and storm water projects. Voters also are asked to consider two reassignments of previously passed bond issues. Meanwhile, there's another vote to hike the city's hotel/motel tax from 4 percent to 7 percent.

Complexity is always a problem on public works proposals. The concern is that voters will be confused by the multiple facets and vote against the whole lot.

The hotel/motel tax hike has drawn organized opposition. The owner of two local hotels has voiced concerns that there isn't enough definition about how the money will be used and that it will hurt local business. Three Broken Arrow legislators are urging voters to reject the tax.

We hope Broken Arrow voters will look at the eight questions individually, and if they do, they will approve all seven bond proposals. The state's fourth largest city needs funding to accommodate its fast-growing population. The \$36.475 million street bond proposal seems especially justified.

The projects publicly discussed for funding with the tax money are all related to tourism, but opponents say they aren't likely to bring local hotels more overnight guests. We suspect the hotel owners know their own industry, but that doesn't necessarily decide the issue. The purpose of a hotel/motel tax isn't to encourage people to stay at hotels and motels.

Broken Arrow voters will have to decide whether they trust their city government's judgment enough to approve a hotel/motel tax increase that will be paid by visitors to the city. In the end, the measure is an interesting opportunity to take the temperature of local voters.
