Drivers Urged to be Cautious of Overnight Construction Monday Night on 9th Street & Hillside Drive

Broken Arrow, Okla. (10/13/2014) – A City of Broken Arrow contractor will be working on the intersection of 9th Street (Lynn Lane) and Hillside Drive beginning at 10:00 p.m. tonight, Monday, October 13, weather permitting. This schedule will minimize impact on traffic and maximize the safety of workers.

While the intersection will remain open during the milling process, drivers need to be aware of shifting lanes of travel. Authorities also ask motorists to drive with caution, as staff and equipment will be on the roadway working through the overnight hours. The milling work on the intersection is expected to be completed before rush hour traffic on Tuesday.

Additionally, weather permitting, resurfacing of the entire southbound lanes from Albany Street through the Hillside Drive intersection is scheduled to start Wednesday the 15th.

Asphalt Overlay of 9th Street (Lynn Lane) to Begin

Broken Arrow, Okla. (10/14/2014) – A City of Broken Arrow contractor will begin laying asphalt on the southbound lanes of 9th Street from Albany (61st Street) to the Broken Arrow Expressway at 10:00 a.m. on Wednesday, October 15th, weather permitting.

Once the asphalt has been placed on the southbound lanes, traffic will be switched over to the new surface on Thursday, October 16th, and the contractor will begin the asphalt overlay on the northbound lanes.

Due to the close proximity of vehicular traffic to equipment and workers, drivers are urged to proceed with caution and pay close attention to road crews, who will likely be giving directions (flagging) at Albany and 9th, as well as the Hillside Drive intersection.

The 9th Street widening project is expected to be completed by November 2.

Re: UPDATE: Transport of Oversized Load Rescheduled to Saturday, Oct. 18

The transport of the oversized load that was postponed last week has been rescheduled to this Saturday, October 18 at 7:00 a.m.

Because of the rolling road closures, the public is asked to make alternate travel plans around the route. Drivers should note that the intersection of SH 51 and E. Houston could be closed for up to 30 minutes while the load clears the grade. That closure will take place around 7:00 a.m., as it is the beginning of the route.

As the movement of this load will require the disabling of the traffic signal at 9th and New Orleans, drivers will need to abide by the posted stop sign at that intersection. Officers from the Broken Arrow Police and Oklahoma Highway Patrol will be involved in the escort of this load, so drivers should watch for directions from authorities.

The affected roadways will re-open as soon as the load has passed.


Re: Development Services Report

1. Exterran Oversize Load — Over the past week, City staff have been working with Exterran, located at the northwest corner of Highway 51 and Houston Street, and Northwest Logistics regarding the moving of an oversized load. The size of the load is 18' high, 18' wide and 427' 10" long and weighing almost 1.2 million pounds. The move date is Saturday, October 11, 2014 beginning at 4:00 am. The load will be moved at approximately 15 mph and take a route from Exterran as follows: West on Houston to 9th Street; south on 9th Street to New Orleans; west on New Orleans to Highway 64 (Memorial Drive), with a final destination in the state of Colorado.

The Broken Arrow Police Department, Highway Patrol and Northwest Logistics will provide escort services. Other City staff from Development Services and General Services Electrical division will be available for assistance. Using this route, the escorts will minimize traffic flow interruptions. Two photos of a load that is 186' long, but similar in configuration as the one to be moved this coming Saturday is attached.

Re: Road Salt Supply Update

Reference Resolution No. 855, that was approved by Council on October 7, 2014. This resolution granted a waiver to the normal purchasing policies and procedures for formal bids to acquire and purchase road salt and granted the City Manager the authority to acquire and purchase road salt up to a limit of \$150,000 for the winter season of 2014-2015. The following actions have been taken resulting from this approval:

- 1. An agreement with Bingham Sand and Gravel to deliver an additional 600 tons of road salt at \$82.50 per ton, for a total cost of \$49,500.00
- 2. An agreement with Kunshek Trucking to deliver 600 tons of road salt at \$100.00 per ton, for a total cost of \$60,000.00.

The total tonnage of road salt that should be stockpiled by November 30, 2014, is 1800 tons. This quantity of salt should be an adequate supply for this winter season.



Battle Creek Golf Club - September Review

General

September was another extremely busy month with over 889 tournament rounds for the month. This exceeded budgeted tournament rounds by 239 rounds. This also helped Green Fee Revenues (+6,159), Food & Beverage operations (+\$5,565) and merchandise sales (+\$3,714) exceed budgeted revenues as well. The result was total revenues for the month was \$17,898 higher than budgeted revenues. Warm, mild weather conditions for September also attributed to a very successful month.

Golf Operations

Battle Creek Golf Club in the month of September had 13 outside events as well as our Club Championship. Overall September was a good revenue month for the club as memberships are up from the previous year as well as golf shop revenue. During the month all outside staff were trained on proper safety procedures and proper opening and closing procedures. Moving into October we will be starting to work on winter projects like cleaning, organizing, painting, and maintenance of our cart fleet.

Course Maintenance

Although September was very warm and dry this year we did receive 1.75 inches of rain this month. With the temps up and being very dry we did apply wetting agents as needed on the course.

The maintenance team did accomplish many tasks this month as well as our seasonal scheduled mowing's, these tasks include: Needle tining greens to improve air and water flow, spot spraying post -emergent herbicides to weeds, fertilizing the entire golf course with an organic fertilizer to help the grasses build food reserves to over winter better, sprayed greens with fungicides and insecticide as needed, we did spray some of the trees along homeowner fence lines that had some army worms beginning to infest, over seed the driving range tees and par 3 tee boxes with ryegrass, top-dressed and groomed greens to improve playability, irrigation repairs as needed(we did see an increase in irrigation repairs during the dry weather), mowed all native areas.

Next month we will begin to winterize the course. We will apply pre-emergent herbicides to green surrounds, begin to stockpile resources to do some tee improvements and some irrigation improvements.

Subject: Fraudulent Phone Calls

The Broken Arrow Police Department would like to make people aware of an ongoing phone scam. The caller will claim to be with a government agency such as the IRS, the U.S. Citizenship and Immigration Services, or even a local law enforcement agency. The caller states money is owed for back taxes or a warrant that was not paid and the victim will be arrested unless the money is paid today. The caller may have some basic information about the victim which is an effort to give legitimacy to the phone call. The caller will demand the victim use a prepaid card and give the caller the numbers of that card over the phone. The caller will give directions on how to purchase the cards and occasionally stays on the line with the victim as the victim purchases the card. The caller will make threats such as arrests, freezing of assets, and even deportation if the victim does not agree to pay the caller using the prepaid card.

Some things to remember:

Government agencies will not call you asking for money.

Government agencies will not ask you to pay with a prepaid card.

Government agencies will not make the threats these callers make, for example, send the police to your house.

If you receive a call similar to this do not give them money, simply tell them you will contact the agency from the legitimately listed phone number and verify the accuracy of the phone call. You can always contact the local police department for assistance with these calls.
