1. District 222, Partial Main Street Closure for Crane - The Ross Group (RG) Contractor has requested their 3rd partial closure of the west parking spaces and southbound lane of Main Street near Dallas Street on Monday, November 10, 2014. The crane will be set up in the early morning and be moved out by 10:30 am. They will be placing the lumber wall sections, lumber beams and wood trusses for the 3<sup>rd</sup> floor.


Traffic cones and flag persons will be used to direct traffic during the partial lane closure. A sketch of the closure is provided.



# Vision 2025 money coming to BA

The City of Broken Arrow found out it will receive, over two years, \$19.6 million from the Vision 2025 Sales Tax Fund, it was announced Tuesday night, Nov. 4.

The City Council wasted no time approving its wish list of things that the money will allocated to fix, repair or improve. That was the good news on the income front.

On the other side of the account ledger, the Broken Arrow Municipal Authority (BAMA) painted an expensive picture of what it will take to improve fire hydrant flow in "Old Town" Broken Arrow. The cost to upgrade aged four-inch water lines, eight-inch water lines and 12-inch lines will cost an estimated \$5.6 million.

Acting City Manager, Russell Gale, outlined the uses for the Vision 2025 money. The biggest amount (\$11.2 million) will go to capital improvements.

The water news for BAMA was given by Jay Updike, president of Holloway, Updike and Bellen, Inc. Updike presented a picture of needed improvements for water flow to fire hydrants. He also had pictures of the aging 4-inch lines that were badly in need of replacement.

"I'm glad you are sitting down," Updike said to the BAMA members before giving the cost of upgrading lines mostly in the city center and just outside the Rose District.

"The 4-inch lines have gotten smaller," Updike said of the clogged lines. "It's just old."

No action was taken on the Old Town Water Distribution Model and Improvement Plan.

The Broken Arrow Economic Development Corporation presented the award given by the International Economic Development Council during a meeting in Fort Worth recently. Only two cities won this highest honor and caught the attention of Mayor Craig Thurmond.

"That was a top award," Thurmond said. "It's pretty amazing."

That was one of two honors the city received.

The Tulsa Young Professionals Organization gave the city the Creative Catalyst Award. This award was in recognition for the Rose District revitalization.

- ❖ Holiday Tea-Off: Hosted by the Broken Arrow Merchants Association is scheduled for November 13<sup>th</sup>, from 6:00 p.m. to 9:00 p.m. They will have Christmas Carolers and music to welcome the holiday season. Main Street from Dallas to Broadway will be closed from 3:00 p.m. to 9:30 p.m. the day of the event. Acting City Manager has reviewed and approved road closure.
- ❖ Heart of Broken Arrow Crafts Fair: Event is scheduled for November 15<sup>th</sup> at the Broken Arrow Community Center. They will have a trolley available for rides. No road closures have been requested or anticipated.
- Ruts and Guts: Event is scheduled for December 6<sup>th</sup> and 7<sup>th</sup> at the Events Park. This is a nationally recognized event and we are expecting attendance of over 300 participants. The organizers have voiced a desire to make this an annual event at the Events Park. No road closures have been requested or anticipated.
- ❖ Camp Bandage: Event is scheduled for May, 2015 at the Events Park. I will be meeting with them in November to finalize the site arrangements for the event.
- ❖ Special Events Committee: Meeting was held October 16<sup>th</sup>. To date the committee has reviewed 71 applications for 2014 events and 4 for 2015.
- ❖ Movie Shoot: I met with Todd McNutt regarding movie shoot in Broken Arrow in April, 2015. He would like to shoot scenes in the downtown area for a large budget film. We will be meeting again to discuss further details.
- ❖ ABLE Commission: October 22<sup>nd</sup>, Capt. Fairchild with the ABLE Commission spoke with City staff to discuss our ordinances and licensing for alcohol being sold within the city. Representatives from Development Services, Police, Recreation, Parks, Cultural Affairs and Tourism and Legal Departments were in attendance. Later in the afternoon, Capt. Fairchild and City staff met with local business owners and event organizers to discuss the process and for all to get a better understanding of the requirements for permits. I have received great feedback from this class from the attendees.
